## **NET ASSET BACKING**

The Directors advise that the unaudited net tangible asset backing of the Company's ordinary shares at 28 February 2021 was \$4.78 per share after provision for the interim dividend of 7.0 cents per share payable on 17 March 2021 (31 January 2021 \$4.79 per share before provision for the interim dividend). The net asset backing calculation is based on investments at market value, is after tax on net realised gains, before any future tax benefit of net realised losses and before estimated tax on net unrealised gains/losses.

Diversified United Investment Limited is a long term investor and does not intend disposing of its total portfolio. However, under current accounting standards the Company is required to provide for estimated tax on any net gains that would arise on such a theoretical disposal. After deducting this provision, the above figure would be \$3.99 (31 January \$4.02).

At 28 February 2021:

- International equities funds comprised 18.7% of the portfolio;
- Bank facilities were \$115M drawn as to \$87.5M;
- Cash and net short term receivables were \$8M.
